TRANSFER AND THE SPECTRAL SEQUENCE OF A FIBRATION

ABSTRACT. The purpose of this paper is to show that transfers for fibrations behave well with respect to spectral sequences which are induced by filtrations of the base space. In particular, for the spectral sequence of a fibration (induced by the skeletal filtration of the base space), one obtains the expected effect on the E_2 -terms: We prove that the transfer in the E_2 -terms is determined by the transfer of the fiber (considered trivially as a fibration over a point). As an application, results of Atiyah on the K-theory of classifying spaces are transcribed to generalized cohomology theories.

This paper is a condensed version of Chapters I-III of my doctoral thesis [10], albeit without the assumption that the fibrations involved have to be *orientable*. I am indebted to Professor Albrecht Dold under whose direction I wrote my thesis.

Introduction. Let \Im be a class of commutative *triangles* of topological spaces and continuous maps

$$(0.1) E \supset V \xrightarrow{f} E$$

$$\pi \searrow \qquad \swarrow \pi$$

$$B$$

where V is open in E. This class is to be closed under pullbacks, namely, if (0.1) lies in \Im and $g: B' \to B$ is continuous, then the induced triangle

(0.2)
$$E' \supset V' \xrightarrow{f'} E'$$

$$\pi' \searrow \qquad \swarrow \pi'$$

$$B'$$

obtained by taking pullbacks over g must lie in $\mathfrak T$. We call such a class $\mathfrak T$ a au-class.

Let h be a cohomology (homology) theory and \mathfrak{I} a τ -class; a *transfer* on \mathfrak{I} for h will associate to *each* triangle (0.1) in \mathfrak{I} a homomorphism

$$\tau(f)$$
: $h(E, E_A) \to h(B, A)$

(or on the opposite direction if h is a homology theory), called the *transfer* of (0.1), where $A \subset B$ and $E_A = \tau^{-1}(A)$.

Such a transfer is to have the following properties: (we shall formulate only the cohomology case; for homology one has corresponding properties)

0.3. Naturality. If $g: B' \to B$ is continuous and $A' \subset B'$ is such that $g(A') \subset A$, then the diagram

$$(0.4) \qquad h(E, E_A) \stackrel{\bar{g}^*}{\to} h(E', E'_{A'})$$

$$\tau(f) \downarrow \qquad \qquad \downarrow \tau(f')$$

$$h(B, A) \stackrel{g^*}{\to} h(B', A')$$

is commutative, where $\tau(f')$ is the transfer of (0.2) and $\bar{g}: E' \to E$ is the canonical map.

0.5. Stability. Let $(\Delta^p, \dot{\Delta}^p)$ be the elementary *p*-simplex and its boundary. Pulling back (0.1) over the projection $\Delta^p \times B \to B$ we get the triangle

$$(0.6) \Delta^p \times E \supseteq \Delta^p \times V \xrightarrow{\operatorname{id} \times f} \Delta^p \times E$$

which admits a transfer such that the square

$$(0.7) \qquad h^{q}(E, E_{A}) \stackrel{\sigma^{p}}{\rightarrow} h^{p+q}((\Delta^{p}, \dot{\Delta}^{p}) \times (E, E_{A}))$$

$$\tau(f) \downarrow \qquad \qquad \downarrow \tau(\mathrm{id} \times f)$$

$$h^{q}(B, A) \stackrel{\sigma^{p}}{\rightarrow} h^{p+q}((\Delta^{p}, \dot{\Delta}^{p}) \times (B, A))$$

commutes, where σ^p denotes the p-iterated suspension isomorphism.

0.8. Equivalent to 0.5 is the *compatibility with the boundary homomorphisms* of the cohomology theory, i.e. $\tau(f)\delta = \delta\tau(f)$.

Besides these general properties of the transfer, one has another which will be of special interest in what follows.

0.9. If the triangle

$$F \supset U \xrightarrow{f_0} F$$

$$\pi_0 \searrow \qquad \swarrow \pi_0$$
*

lies in a τ -class admitting a transfer for a theory h and for singular cohomology H, then

$$\tau(f_0)\pi_0^* = \Lambda(f_0)\cdot:h(*)\to h(*)$$

where $\Lambda(f_0) = \tau(f)(1) \in H^0(*) = \mathbb{Z}$, $1 \in H^0(F)$ for the transfer in singular cohomology. This number is called the *Lefschetz-Hopf index* of f_0 .

0.10. N.B. In many cases $\Lambda(f_0)$ agrees with the Lefschetz-number of f_0 (when it is defined), see [3, §§2, 3] and/or [6, VII.6.6].

0.11. As a corollary of 0.9 it follows that if F is 0-connected, then $\tau(f_0) = \Lambda(f_0)\eta^*$: $h(F) \to h(*)$, where $\eta: * \to F$ is any map.

Up to here we have talked quite abstractly about the transfer. I shall now mention some concrete examples.

0.12. If \mathfrak{I} is the class of all finite coverings π : $E \to B$ (considered as triangles with V = E and f = id) one has the Atiyah-transfer [2] (direct image) for K-theory

$$\tau(\mathrm{id}) = \pi_1: K(E) \to K(B)$$

and the transfer first defined by Eckmann [8] in singular theories, say

$$\tau(\mathrm{id})\colon H^*(E)\to H^*(B)$$
.

This was extended to all generalized cohomology theories, since it is induced by a suitable map of spectra as shown by Roush. See [1] for a detailed discussion.

- 0.13. For the class \mathfrak{T} of triangles (0.1) such that $\pi \colon E \to B$ is an ENR_B with B metric and f compactly fixed (and all their pullbacks) Dold constructed a transfer in [7] for all cohomology theories (over B), and
- 0.14. For the class \mathfrak{T} of triangles (0.1) such that $\pi\colon E\to B$ is a Hurewicz-fibration with fiber F (homotopy-equivalent to) a finite CW-complex, basis B (homotopy-equivalent to) a finite dimensional CW-complex and V=E (and the pullbacks of such triangles), Becker and Gottlieb [3] defined also a transfer, further generalized by M. Clapp de Prieto [4, 5] to a basis B without any restriction on the dimension.

In all cases one may show that the constructed transfers have all mentioned properties (and others).

- 1. The transfer and the spectral sequence of a filtration. From now on we shall say briefly that a given triangle (0.1) admits a transfer for a theory h if it belongs to a τ -class \Im for which a transfer for h can be defined.
 - 1.1. Let (0.1) admit a transfer and take a filtration of the pair (B, A)

$$\mathfrak{B}: A = B^{-1} \subset B^0 \subset \cdots \subset B^n \subset B^{n+1} \subset \cdots \subset B^{\infty} = B$$

and the induced filtration of the pair (E, E_A)

$$\mathcal{E}\colon E_A=E^{-1}\subset E^0\subset\cdots\subset E^n\subset E^{n+1}\subset\cdots\subset E^\infty=E,$$

that is, $E^n = \pi^{-1}(B^n)$, $n = -1, 0, 1, \dots, \infty$. Take $k \le l \le m \le n$ and consider

where all squares are pullback diagrams. From the naturality of the transfer, 0.3, we know that the square

(1.2)
$$h(E^{n}, E^{l}) \rightarrow h(E^{n}, E^{k})$$

$$\tau \downarrow \qquad \qquad \downarrow \tau$$

$$h(B^{n}, B^{l}) \rightarrow h(B^{n}, B^{k})$$

commutes, where the horizontal arrows are induced by the corresponding inclusions and τ denotes the transfers of the corresponding restrictions of f.

The compatibility of τ with boundary homomorphisms 0.8 gives us the commutative square

(1.3)
$$h(E^{l}, E^{k}) \stackrel{\delta}{\to} h(E^{m}, E^{l})$$

$$\tau \downarrow \qquad \qquad \downarrow \tau$$

$$h(B^{l}, B^{k}) \stackrel{\delta}{\to} h(B^{m}, B^{l})$$

where δ denotes the boundary homomorphisms of the triples $E^k \subset E^l \subset E^m$ and $B^k \subset B^l \subset B^m$ respectively.

Since all groups mentioned and all horizontal arrows are the ones taken into account for defining the spectral sequences of the filtrations \mathfrak{B} and \mathfrak{E} respectively, it is straightforward to prove using (1.2) and (1.3) the following

1.4. Theorem. $\tau(f)$ induces a transformation of spectral sequences

$$\tau: \{E_r, d_r\} \to \{\overline{E}_r, \overline{d}_r\}$$

where $\{E_r, d_r\}$ is the spectral sequence induced by the filtration $\mathscr E$ and $\{\overline E_r, \overline d_r\}$ the one induced by $\mathscr B$.

(Cf. [11, 15.56] for the definition of a transformation of spectral sequences.) \Box

- 2. The transfer and the spectral sequence of a fibration.
- 2.1. To begin, let us recall the theorem of Leray-Serre for general theories.

Suppose $\pi\colon E\to B$ is a (Hurewicz-) fibration and $A\subset B$ is so that (B,A) is a 0-connected relative CW-complex., Take as $\mathfrak B$ in §1 the skeletal filtration of (B,A) and as $\mathfrak E$ the induced filtration of (E,E_A) . Let h be a strongly additive cohomology theory (or just an arbitrary one if (B,A) has only finitely many cells in each dimension). One has

2.2. Theorem (Leray-Serre). The spectral sequence associated to \mathcal{E} , $\{E_r, d_r\}$, converges to $h(E, E_A)$ and there is an isomorphism

$$E_2^{pq} \cong H^p(B, A; h^q(\mathfrak{F}))$$

where H^* means singular (or cellular) cohomology with coefficients taken in the local system of coefficients given by $h^q(\pi^{-1}(b))$, $b \in B$, as usual (and correspondingly for a homology theory).

I shall not prove the theorem and just refer the reader to [12, XII.4.9 and 4.9*]. I will only show what the isomorphism looks like.

2.3. First of all I describe the local system $h(\mathcal{F})$. This is a contravariant functor

$$h(\mathfrak{F}):\Pi_1(B)\to \mathrm{Ab}$$

from the fundamental groupoid of B to abelian groups, such that

$$h(\mathfrak{F})(b) = h(F_b), \quad F_b = \pi^{-1}(b)$$

and if $\omega: I \to B$ is a path from b_0 to b_1 then $h(\mathfrak{T})(\omega) = \overline{\omega}^*$, where $\overline{\omega}: F_{b_0} \to F_{b_1}$ is given by $\overline{\omega}(y) = \lambda(y, \omega)(1)$ and $\lambda(y, \omega)$ is a path over ω beginning at y and lying over ω (say, given by a lifting function λ).

2.4. The cellular cocomplex with coefficients in $h^q(\mathfrak{F})$ associated to the skeletal filtration \mathfrak{B} of (B, A) has as pth group

$$\Gamma^p(B,A;h^q(\mathfrak{F}))=\prod_{\phi\in\Phi_p}h^qig(F_{\phi(e_0)}ig)$$

where Φ_p is the set of all characteristic maps of the *p*-cells of (B, A) considered as maps $\phi: (\Delta^p, \dot{\Delta}^p) \to (B^p, B^{p-1})$ and $e_0 = (1, 0, 0, \dots, 0) \in \Delta^p \subset \mathbb{R}^{p+1}$ (cf. [12]).

2.5. Take a characteristic map ϕ as before and pull back $E^p \to B^p$ over ϕ :

$$T_{\phi} \stackrel{\psi}{\rightarrow} E^{p}$$
 $\downarrow \qquad \qquad \downarrow$
 $\Delta^{p} \stackrel{\phi}{\rightarrow} B^{p}$

Since Δ^p is contractible (to e_0), there is a (well-defined, up to vertical homotopy) trivialization

$$\alpha_{\phi} \colon \Delta^p \times F_{\phi(e_0)} \stackrel{\simeq}{\to} T_{\phi}$$

(i.e. fiber homotopy equivalence such that $\alpha_{\phi}(e_0,-) \simeq \mathrm{id}$). The isomorphism κ : $E_1^{pq} = h^{p+q}(E^p, E^{p-1}) \to \Gamma^p(B, A; h^q(\mathfrak{F}))$ is given by the composite

$$h^{p+q}(E^p, E^{p-1}) \overset{\psi^*}{\to} h^{p+q}(T_{\phi}, \dot{T}_{\phi}) \overset{\alpha_{\phi}^*}{\to} h^{p+q}((\Delta^p, \dot{\Delta}^p) \times F_{\phi(e_0)}) \overset{\sigma^p}{\overset{}\leftarrow} h^q(F_{\phi(e_0)})$$

in each factor, where \dot{T}_{ϕ} is the restriction of T_{ϕ} to the boundary of Δ^p , $\dot{\Delta}^p$, and σ^p is the *p*-iterated suspension isomorphism.

2.6. In case that E = B and the projection is the identity, then the local coefficient system $h^q(\mathfrak{F})$ becomes the global coefficient group $h^q(*)$ and κ turns out to be very simple; that is, $\bar{\kappa}$: $\bar{E}_1^{pq} = h^{p+q}(B^p, B^{p-1}) \to \Gamma^p(B, A; h^q(*))$ is defined by

$$h^{p+q}(B^p, B^{p-1}) \stackrel{\phi^*}{\rightarrow} h^{p+q}(\Delta^p, \dot{\Delta}^p) \stackrel{\sigma^p}{\leftarrow} h^q(*).$$

This $\bar{\kappa}$ gives the isomorphism of the *Atiyah-Hirzebruch-Whitehead spectral sequence*.

2.7. Let now $\tilde{\pi}$: $\tilde{E} \to B \times I$ be a Hurewicz-fibration with lifting map $\tilde{\lambda}$. Let i_{ν} : $B \approx B \times \{\nu\} \hookrightarrow B \times I$ be the inclusion $(\nu = 0, 1)$. Call $E^{\nu} \subset \tilde{E}$ the restriction (pullback) of E over i_{ν} . We shall construct a homotopy equivalence over B, $\bar{\omega}$: $E^0 \to E^1$ as follows. Given $e \in \tilde{E}$ let $\tilde{\pi}e = (\pi e, se) \in B \times I$, whence $e \in E^{\nu}$ if and only if $se = \nu$. For $e \in E^0$ define the path ω_e : $I \to B \times I$ by $\omega_e(t) = (\pi e, t)$. Now let

$$\overline{\omega}(e) = \tilde{\lambda}(e, \omega_e)(1) \in E^1$$

which is well defined since $\tilde{\pi}e = (\pi e, 0) = \omega_e(0)$. One may easily show that this is a fiber homotopy equivalence.

The following lemma will be of interest in what follows.

2.8. LEMMA. Suppose that the triangle

$$\begin{array}{ccc} \tilde{E} \supset \tilde{V} & \stackrel{\tilde{f}}{\rightarrow} & \tilde{E} \\ & & & \swarrow \tilde{\pi} \\ & & & B \times I \end{array}$$

admits a transfer for h, where $\tilde{\pi}$ is as above, and let $A \subset B$. If f^{ν} : $V^{\nu} \to E^{\nu}$ denotes the restriction of \tilde{f} to $B \times \{\nu\}$, then the diagram

$$h(E^0, E_A^0) \stackrel{\overline{\omega}^*}{\leftarrow} h(E^1, E_A^1)$$
 $\tau(f^0) \searrow \qquad \qquad \swarrow \tau(f^1)$
 $h(B, A)$

is commutative.

PROOF. Let $j_{\nu} : E^{\nu} \to \tilde{E}$ be the inclusion. By naturality we obtain

$$h(E^{0}, E_{A}^{0}) \stackrel{j_{0}^{*}}{\leftarrow} h(\tilde{E}, \tilde{E}_{A \times I}) \stackrel{j_{1}^{*}}{\rightarrow} h(E^{1}, E_{A}^{1})$$

$$\downarrow \tau(f^{0}) \qquad \downarrow \tau(\tilde{f}) \qquad \downarrow \tau(f^{1})$$

$$h(B, A) \stackrel{i_{0}^{*}}{\leftarrow} h((B, A) \times I) \stackrel{i_{1}^{*}}{\rightarrow} h(B, A).$$

Whence $\tau(f^0)j_0^* = \tau(f^1)j_1^*$ since $i_1^*(i_0^*)^{-1} = 1$. We now construct a map $k \colon \tilde{E} \to E^1$ such that (i) $kj_1 \simeq \mathrm{id}_{E^1}$ and (ii) $kj_0 = \overline{\omega}$, thus proving the lemma: For $e \in E$ let $\tilde{\omega}_e(t) = (\pi e, (1 - se)t + se)$. One may easily check that

$$k(e) = \tilde{\lambda}(e, \tilde{\omega}_e)(1)$$

is well defined and satisfies (i) and (ii).

We apply this lemma to obtain the following

2.9. Proposition. Let (0.1) admit a transfer and be such that π is a fibration. Then the transfer defines a transformation of coefficient systems

$$\tau: h(\mathfrak{F}) \to h(*)$$

such that for each $b \in B$, $\tau_b = \tau(f_b)$: $h(F_b) \to h(*)$ for the pullback diagram

 $over * \rightarrow \{b\} \hookrightarrow B$.

PROOF. Let $\omega\colon I\to B$ be a path from b_0 to b_1 . If $\tilde\pi\colon \tilde E\to I$ is the pullback of E over ω we fall in the case described above and the $\bar\omega\colon F_{b_0}\to F_{b_1}$ defined in 2.3 agrees with the $\bar\omega\colon E^0\to E^1$ defined in 2.7. Hence the lemma states that the diagram

$$h(F_{b_0}) \stackrel{\tau(f_{b_0})}{\rightarrow} h(*)$$
 $\overline{\omega}^* \downarrow \qquad \qquad \parallel$
 $h(F_{b_1}) \stackrel{\tau(f_{b_1})}{\rightarrow} h(*)$

commutes, thus proving the naturality of τ . \square We need also the following corollary of 2.8.

2.10. PROPOSITION. In the situation (0.1) let π : $E \to B$ be a fibration with B contractible and take a trivialization α : $B \times F \to E$. Then the triangle

$$h(E, E_A)$$
 $\stackrel{\alpha^*}{\to}$ $h((B, A) \times F)$
 $\tau(f) \setminus \qquad \qquad \swarrow \tau(\operatorname{id} \times f_0)$
 $h(B, A)$

commutes, where f_0 is the restriction of f to the point $b_0 \in B$ to which B contracts.

PROOF. Let $H: B \times I \to B$ be a contraction such that $H(b,0) = b_0$, H(b,1) = b. Take the induced triangle

$$\begin{array}{cccc} \tilde{E} \supset \tilde{V} & \stackrel{\tilde{f}}{\rightarrow} & \tilde{E} \\ & & & \swarrow \tilde{\pi} \\ & & & & \swarrow \tilde{\pi} \end{array}$$

by pulling back (0.1) over H. From Lemma 2.8 we know that

(1)
$$\tau(f^0)\overline{\omega}^* = \tau(f^1)$$

holds. We have that E^0 is the pullback of E over the map $B \to \{b_0\} \hookrightarrow B$, whence $E^0 = B \times F$ ($F = \pi^{-1}(b_0)$) and f^0 : $B \times (F \cap V) \to B \times F$ is such that $f^0(b, e) = (b, f(e))$, i.e. $f^0 = \operatorname{id} \times f_0$. ($f_0 = f \mid F$.) On the other hand E^1 is the pullback of E over the identity, thus $E^1 = E$ and $f^1 = f$. Under these identifications $\overline{\omega}$ becomes a trivialization which is vertically homotopic to α , whence (1) becomes

$$\tau(\mathrm{id} \times f_0)\alpha^* = \tau(f)$$

as desired. \square

2.11. THEOREM. The diagram

$$h^{p+q}(E^p, E^{p-1}) \stackrel{\kappa}{\to} \Gamma^p(B, A; h^q(\mathfrak{F}))$$

$$\tau(f) \downarrow \qquad \qquad \downarrow \Gamma^p(B, A; \tau)$$

$$h^{p+q}(B^p, B^{p-1}) \stackrel{\kappa}{\to} \Gamma^p(B, A; h^q(*))$$

is commutative.

PROOF. It is enough to check the commutativity of the diagram

which can be performed by doing it separately for the subdiagrams I, II and III. I commutes by the naturality, 0.3, of $\tau(f)$, III commutes by the stability, 0.5, of $\tau(f_{\phi(e_0)})$. The commutativity of II follows from 2.10. \square

We obtain our main theorem now immediately as a corollary of 2.11:

2.12. THEOREM. Consider the triangle (0.1) such that $\pi: E \to B$ is a fibration over a relative CW-complex (B, A), and a strongly additive cohomology theory h for which it admits a transfer. Then this transfer induces a transformation from the spectral sequence of the fibration to the Atiyah-Hirzebruch-Whitehead spectral sequence of B

$$\tau(f): \{E_r, d_r\} \to \{\overline{E}_r, \overline{d}_r\}$$

converging to $\tau(f)$: $h(E, E_A) \to h(B, A)$ in such a way that for the E_2 -terms, the diagram

$$E_2^{pq} \cong H^p(B, A; h^q(\mathfrak{F}))$$

$$\tau(f) \downarrow \qquad \qquad \downarrow H^p(B, A; \tau)$$

$$\bar{E}_2^{pq} \cong H^p(B, A; h^q(*))$$

commutes, where $\tau_b = \tau(f_b)$: $h^q(F_b) \to h^q(*)$ is the transfer of the restriction to each fiber. \square

- N.B. For a cohomology theory which sends weak homotopy equivalences to isomorphisms, there is, of course, no need to restrict ourselves to relative CW-complexes: the theorem holds for any pair (B, A) by giving a CW-approximation of it as usual.
- 2.13. There is a homology version of all this, which can be obtained in the same way. I omit the details.
 - **3. Applications.** We apply 2.12 to vary some results in [2].
 - 3.1. Suppose that B is a CW-complex and recall that

$$F^{n} = \operatorname{Ker}(h(E) \to h(E^{n-1})),$$

$$\overline{F}^{n} = \operatorname{Ker}(h(B) \to h(B^{n-1})),$$

by definition. Define the associated graded groups of the filtered groups h(E) and h(B) by

$$\mathfrak{G}h(E) = \bigoplus_{n} F^{n}/F^{n+1} = \bigoplus_{n} E_{\infty}^{n}$$

and

$$\mathfrak{G}h(B) = \bigoplus_{n} \overline{F}^{n}/\overline{F}^{n+1} = \bigoplus_{n} \overline{E}_{\infty}^{n}.$$

3.2. THEOREM (CF. [2, 2.11]). Take a fibration π : $E \to B$ and a map f: $V \to E$ (V open in E) over B such that it has a transfer. Then $\Lambda = \Lambda(f_0)$ ($f_0 = f \mid F \cap V$, $F = \pi^{-1}(b_0)$) annihilates the kernel of

$$\pi^* \colon \mathcal{G}h(B) \to \mathcal{G}h(E).$$

If p is a prime number not dividing Λ , $H^n(B)$ is finitely generated for all n (e.g. if the n-skeleton B^n is finite for all n) and h(*) is a finitely generated group, then the p-primary component of $\mathfrak{G}h(B)$ is a direct summand of $\mathfrak{G}h(E)$. Moreover, if the filtration of h(B) is finite (e.g. if B is finite), then the p-primary component of h(B) is a direct summand of h(E).

PROOF. The composite

$$\tau(f)\pi^* \colon \mathcal{G}h(B) \to \mathcal{G}h(B)$$

is multiplication by Λ , since this is the case in the E_2 -terms and whence also in the E_{∞} -terms. Thus the first part of the theorem.

Let now $T^p(n)$ be the *p*-primary component of \overline{E}^n_∞ which is a direct summand by the theorem of primary decomposition, since \overline{E}^n_∞ is finitely generated as one may prove by using the spectral sequence \overline{E}^n_r and the assumptions on $H^*(B)$ and h(*). The diagram

$$\begin{array}{ccccc}
\overline{E}_{\infty}^{n} & \stackrel{\pi^{*}}{\to} & E_{\infty}^{n} & \stackrel{\tau(f)}{\to} & \overline{E}_{\infty}^{n} \\
\uparrow & & & & & \downarrow \\
T^{p}(n) & \stackrel{\Lambda \cdot}{\to} & T^{p}(n)
\end{array}$$

commutes; the lower arrow is mono, since p does not divide Λ , in consequence it is also epi $(T^p(n))$ is finite). This proves the second part. The third is now an easy consequence of the second part. \square

3.3. COROLLARY (CF. [2, 4.8]). Let G be a finite group and BG its classifying space. Then the order of G, o(G), annihilates $\Im \tilde{h}(BG)$. ($\Im \tilde{h}(BG)$ is constructed from the filtration $\tilde{F}^n = \text{Ker}(\tilde{h}(BG) \to \tilde{h}(B^{n-1}))$, with B^{n-1} the (n-1)-skeleton of BG; $F^0 = h(BG)$.)

PROOF. Take the triangle

$$EG \xrightarrow{\text{id}} EG$$

$$\pi \searrow \qquad \swarrow \pi$$

$$BG$$

where $\pi \colon EG \to BG$ is the classifying bundle of G. It does admit a transfer, and since h(EG) = h(*) it follows that $\text{Ker}(\mathcal{G}h(BG) \to \mathcal{G}h(EG)) = \mathcal{G}\tilde{h}(BG)$. Apply the first part of 3.2. \square

3.4. COROLLARY (CF. [2, 4.9]). Suppose that h(*) is a finitely generated group. If G is a finite group, then the p-primary component of $\mathfrak{G}h(BG)$ is a direct summand of $\mathfrak{G}h(BH)$ for each p-Sylow subgroup H of G.

PROOF. The triangle

$$BH \stackrel{\mathrm{id}}{\to} BH$$

$$\searrow \qquad \swarrow$$

$$BG$$

has F = G/H as fiber, and under our hypotheses $\chi_F = [G: H]$ is not divisible by p; whence the result follows from the second part of 3.5. \square

3.5. N.B. Under the same hypotheses of 3.4, it follows from the third part of 3.2 that the p-primary component of $h(B^nG)$ is a direct summand of $h(B^nH)$, where B^nG and B^nH are the corresponding n-skeleta. \square
