

ON TWO DIMENSIONAL MARKOV PROCESSES WITH BRANCHING PROPERTY⁽¹⁾

Introduction. A continuous state branching Markov process (C.B.P.) was introduced by Jirina [8] and recently Lamperti [10] determined all such processes on the half line. (A quite similar result was obtained independently by the author.) This class of Markov processes contains as a special case the diffusion processes (which we shall call *Feller's diffusions*) studied by Feller [2]. The main objective of the present paper is to extend Lamperti's result to multi-dimensional case. For simplicity we shall consider the case of 2-dimensions though many arguments can be carried over to the case of higher dimensions⁽²⁾. In Theorem 2 below we shall characterize all C.B.P.'s in the first quadrant of a plane and construct them. Our construction is in an analytic way, by a similar construction given in Ikeda, Nagasawa and Watanabe [5], through backward equations (or in the terminology of [5] through *S*-equations) for a simpler case and then in the general case by a limiting procedure.

A special attention will be paid to the case of diffusions. We shall show that these diffusions can be obtained as a unique solution of a stochastic equation of Ito (Theorem 3). This fact may be of some interest since the solutions of a stochastic equation with coefficients Hölder continuous of exponent 1/2 (which is our case) are not known to be unique in general. Next we shall examine the behavior of sample functions near the boundaries (x_1 -axis or x_2 -axis). We shall explain, for instance, the case of x_1 -axis. There are two completely different types of behaviors. In the first case x_1 -axis acts as a pure exit boundary: when a sample function reaches the x_1 -axis then it remains on it moving as a one-dimensional Feller diffusion up to the time when it hits the origin and then it is stopped. In the second case, there is a point x_0 on x_1 -axis such that $\Sigma_2 = (0, x_0)$ acts as a reflecting boundary and $\Sigma_1 = (x_0, \infty)$ acts as a pure entrance boundary (Theorem 4 and Corollaries).

1. Definitions and the main theorem. Let $D^\circ = \{x = (x_1, x_2) : x_1 > 0, x_2 > 0\}$, $D = \{x = (x_1, x_2) : x_1 \geq 0, x_2 \geq 0\}$ and $\bar{D} = D \cup \{\Delta\}$ be the one-point compactification of D .

DEFINITION 1.1⁽³⁾. A Markov process $X=(x_t, P_x)$ on \bar{D} is called a *continuous state branching process* (C.B.P.) if it has Δ as a trap and satisfies

$$(1.1) \quad E_x(e^{-\lambda \cdot x_t}) = E_{(1,0)}(e^{-\lambda \cdot x_t})^{x_1} E_{(0,1)}(e^{-\lambda \cdot x_t})^{x_2}$$

for every $\lambda=(\lambda_1, \lambda_2) \gg 0$ and $x=(x_1, x_2) \in D$. The property (1.1) is called the *branching property*.

DEFINITION 1.2. A C.B.P. $X=(x_t, P_x)$ is called *regular* if both $E_{(1,0)}(e^{-\lambda \cdot x_t})$ and $E_{(0,1)}(e^{-\lambda \cdot x_t})$ are differentiable in t at $t=0$ for each fixed $\lambda \gg 0$.

Let Ψ be the set of all functions $\psi(\lambda), \lambda \geq 0$, of the form

$$(1.2) \quad \psi(\lambda) = c_0 + c_1 \lambda_1 + c_2 \lambda_2 + \int_D (1 - e^{-\lambda \cdot u}) n(du)$$

where $c_i \geq 0, i=0, 1, 2$ and $n(du)$ is a nonnegative measure on $D - \{O\}$ ⁽⁴⁾ such that

$$\int_D \frac{|u|}{1+|u|} n(du) < \infty$$

i.e., $\psi(\lambda) \in \Psi$ if and only if $e^{-\psi(\lambda)}$ is the Laplace transform of a substochastic infinitely divisible measure P on D . Let

$$(1.3) \quad \Psi^2 = \Psi \times \Psi = \{\Psi(\lambda) = (\psi_1(\lambda), \psi_2(\lambda)); \psi_i(\lambda) \in \Psi, i = 1, 2\}$$

then there is a one-to-one correspondence between $\Psi \in \Psi^2$ and a pair (P_1, P_2) of substochastic infinitely divisible measures on D . It is easy to see that if Ψ_1 and Ψ_2 are in Ψ^2 then $\Psi_1(\Psi_2) \in \Psi^2$ where $\Psi_1(\Psi_2)$ is defined by

$$(1.4) \quad \Psi_1(\Psi_2)(\lambda) = (\psi_1^{(1)}(\Psi_2(\lambda)), \psi_2^{(1)}(\Psi_2(\lambda)))$$

if $\Psi_1=(\psi_1^{(1)}, \psi_2^{(1)})$. In fact for every $x=(x_1, x_2) \in D$ there exists a unique substochastic infinitely divisible measure $P_x(dy)$ on D such that

$$\exp \{-x_1 \psi_1^{(2)}(\lambda) - x_2 \psi_2^{(2)}(\lambda)\} = \int_D e^{-\lambda \cdot y} P_x(dy)$$

Let $Q_i(dy) (i=1, 2)$ be substochastic infinitely divisible measures on D defined by

$$\exp(-\psi_i^{(1)}(\lambda)) = \int_D e^{-\lambda \cdot y} Q_i(dy).$$

Then $\Psi_1(\Psi_2)$ corresponds to the pair (P_1, P_2) of infinitely divisible measures defined by

$$P_i(dy) = \int_D Q_i(dx) P_x(dy), \quad i = 1, 2.$$

DEFINITION 1.3. A one parameter family $\{\Psi_t\}_{t \in [0, \infty)}$ of elements in Ψ^2 is called a Ψ^2 -semigroup if

$$(1.5) \quad \Psi_{t+s} = \Psi_t(\Psi_s), \quad \Psi_0(\lambda) = \lambda.$$

DEFINITION 1.4. A Ψ^2 -semigroup $\{\Psi_t\}$ is called *regular* if for every $\lambda \gg 0$, $\Psi_t(\lambda)$ is differentiable in t at $t=0$.

Let $X=(x_t, P_x)$ be a C.B.P. and let $P(t, x, dy)$ be the transition probability of X . If we set $P_1(t, dy) = P(t, (1, 0), dy)$ and $P_2(t, dy) = P(t, (0, 1), dy)$ then

$$(1.6) \quad \int_D e^{-\lambda \cdot y} P(t, x, dy) = \exp \{-\psi_1(t, \lambda)x_1 - \psi_2(t, \lambda)x_2\}$$

where

$$(1.7) \quad \exp(-\psi_i(t, \lambda)) = \int_D e^{-\lambda \cdot y} P_i(t, dy), \quad i = 1, 2.$$

Then $\Psi_t(\lambda) = (\psi_1(t, \lambda), \psi_2(t, \lambda)) \in \Psi^2$ for every $t \geq 0$ and by the semigroup property of $P(t, x, dy)$ it is easy to see that $\Psi_{t+s} = \Psi_t(\Psi_s)$, i.e., $\{\Psi_t\}_{t \in [0, \infty)}$ is a Ψ^2 -semigroup. Conversely given a Ψ^2 -semigroup $\{\Psi_t\}$, if we define $P(t, x, dy)$ by (1.6) then it is a substochastic kernel and by the semigroup property of Ψ_t we have

$$P(t+s, x, dy) = \int_D P(t, x, dz) P(s, z, dy).$$

Hence $\{P(t, x, dy)\}$ defines a unique Markov process on $\bar{D} = D \cup \{\Delta\}$ with \bar{D} as a trap. Thus we have the following

THEOREM 1. *There is a one-to-one correspondence between the C.B.P.'s $X=(x_t, P_x)$, and the Ψ^2 -semigroups $\{\Psi_t\}$. The correspondence is given by*

$$(1.8) \quad E_x(e^{-\lambda \cdot x_t}) = \exp \{-x_1 \psi_1(t, \lambda) - x_2 \psi_2(t, \lambda)\}.$$

Furthermore X is regular if and only if $\{\Psi_t\}$ is regular.

Let $\xi_1(x)$ and $\xi_2(x) \in C_0^\infty(D)^{(6)}$ such that $\xi_1(x) = x_1$ and $\xi_2(x) = x_2$ on some neighborhood U of the origin O . The main theorem is the following:

THEOREM 2. *Let $X=(x_t, P_x)$ be a regular C.B.P. Then the semigroup T_t of the process X is a strongly continuous nonnegative contraction semigroup on $C_0(D)^{(6)}$ such that, if A is the infinitesimal generator in Hille-Yosida sense of T_t , we have*

- (i) $C_0^2(D) \subset D(A)^{(6)}$ and
- (ii) for $f \in C_0^2(D)$

$$\begin{aligned}
 Af(x) &= \alpha^2 x_1 f_{11}(x) + \beta^2 x_2 f_{22}(x) + (ax_1 + bx_2) f_1(x) \\
 &\quad + (cx_1 + dx_2) f_2(x) - \gamma x_1 f(x) - \delta x_2 f(x) \\
 (1.9) \quad &+ x_1 \int_D \{f(x+y) - f(x) - \xi_1(y) f_1(x)\} n_1(dy) \\
 &\quad + x_2 \int_D \{f(x+y) - f(x) - \xi_2(y) f_2(x)\} n_2(dy) \quad (*)
 \end{aligned}$$

where $\alpha, \beta, \gamma, \delta, a, b, c, d$ are constants such that

$$(1.10) \quad \gamma \geq 0, \quad \delta \geq 0, \quad b \geq 0, \quad c \geq 0$$

and n_1, n_2 are nonnegative measures on $D - \{O\}$ such that

$$\begin{aligned}
 (1.11) \quad &\int_U \{\xi_1^2(y) + \xi_2(y)\} n_1(dy) + \int_U \{\xi_1(y) + \xi_2^2(y)\} n_2(dy) \\
 &\quad + n_1(D - U) + n_2(D - U) < \infty.
 \end{aligned}$$

Conversely given $a, b, c, d, \alpha, \beta, \gamma, \delta, n_1$ and n_2 with the conditions (1.10) and (1.11) there exists a unique Markov process $X = (x_t, P_x)$ with the semigroup T_t satisfying (i) and (ii) and further X is a regular C.B.P.

If we set

$$(1.12) \quad E_{(1,0)}(e^{-\lambda \cdot x_t}) = e^{-\psi_1(t, \lambda)}, \quad E_{(0,1)}(e^{-\lambda \cdot x_t}) = e^{-\psi_2(t, \lambda)},$$

$$\begin{aligned}
 (1.13) \quad h_1(\lambda) &= -\alpha^2 \lambda_1 + (a\lambda_1 + c\lambda_2) + \gamma - \int_D (e^{-\lambda y} - 1 + \lambda_1 \xi_1(y)) n_1(dy), \\
 h_2(\lambda) &= -\beta^2 \lambda_1 + (b\lambda_1 + d\lambda_2) + \delta - \int_D (e^{-\lambda y} - 1 + \lambda_2 \xi_2(y)) n_2(dy),
 \end{aligned}$$

and

$$(1.14) \quad E_x(e^{-\lambda \cdot x_t}) = F(t, \lambda; x)$$

then $\Psi_t = (\psi_1(t, \lambda), \psi_2(t, \lambda))$ satisfies the backward equation

$$(1.15) \quad d\psi_1/dt = h_1(\Psi_t), \quad d\psi_2/dt = h_2(\Psi_t), \quad \Psi_{0+} = \lambda,$$

and $F(t, \lambda; x)$ satisfies the forward equation

$$(1.16) \quad \frac{\partial F}{\partial t} = h_1(\lambda) \frac{\partial F}{\partial \lambda_1} + h_2(\lambda) \frac{\partial F}{\partial \lambda_2}; \quad F(0+, \lambda; x) = e^{-\lambda \cdot x}.$$

By the correspondence established in Theorem 1 this theorem can be stated in the following purely analytical form:

THEOREM 2'. Let $\Psi_t = (\psi_1(t, \lambda), \psi_2(t, \lambda))$ be a regular Ψ^2 -semigroup. Then there exist $a, b, c, d, \alpha, \beta, \gamma, \delta, n_1$ and n_2 satisfying the conditions (1.10) and (1.11) such that it is given as a solution of the backward equation (1.15) for h_1 and h_2 defined by (1.13).

(*) $f_{ij}(x) = \partial^2 f / \partial x_i \partial x_j$, and $f_i(x) = \partial f / \partial x_i, i = 1, 2.$

Conversely given such $a, b, c, d, \alpha, \beta, \gamma, \delta, n_1$ and n_2 , the solution of the backward equation is unique and defines a Ψ^2 -semigroup.

2. Proof of Theorem 2.

LEMMA 1. Let $\psi_n \in \Psi$ and $\psi_n \Rightarrow \psi^{(8)}$ on a domain $U \subseteq \Lambda = \{\lambda = (\lambda_1, \lambda_2) : \lambda \geq 0\}^{(9)}$. Then $\psi \in \Psi$. (To be precise there exists a unique extension of Ψ onto Λ so that it is an element of Ψ .)

Proof. This lemma may be well known but we shall give a standard proof for the completeness. $\psi(\lambda) \in \Psi$ has the form

$$\begin{aligned} \psi(\lambda) &= c_0 + c_1\lambda_1 + c_2\lambda_2 + \int_D (1 - e^{-\lambda \cdot u})n(du) \\ &= \int_{\Omega} \xi(\lambda; r, \theta)\tilde{n}(dr d\theta) \end{aligned}$$

for some bounded measure $\tilde{n}(dr d\theta)$ on Ω where

$$\begin{aligned} \Omega &= [0, \infty) \times [0, \pi/2] \\ \xi(\lambda; r, \theta) &= \{1 - \exp(-\lambda_1 r \cos \theta - \lambda_2 r \sin \theta)\} \\ &\quad \times (1 + r \cos \theta + r \sin \theta)(r \cos \theta + r \sin \theta)^{-1}. \end{aligned}$$

Clearly we have

$$c_0 = \int_{\{\infty\} \times [0, \pi/2]} \tilde{n}(dr d\theta), \quad c_1 = \int_{\{0\} \times [0, \pi/2]} \frac{\cos \theta}{\cos \theta + \sin \theta} \tilde{n}(dr d\theta)$$

and

$$c_2 = \int_{\{0\} \times [0, \pi/2]} \frac{\sin \theta}{\cos \theta + \sin \theta} \tilde{n}(dr d\theta).$$

Also it is easy to see that for any nonnegative bounded measure \tilde{n} on Ω

$$\psi(\lambda) = \int_{\Omega} \xi(\lambda; r, \theta)\tilde{n}(dr d\theta)$$

is an element in Ψ . Note also that for fixed $\lambda_0 \in U$,

$$(2.1) \quad d_1 \leq \xi(\lambda_0; r, \theta) \leq d_2 \quad \text{for all } (r, \theta) \in \Omega$$

for some constants $0 < d_1 < d_2$. Now let $\psi_n(\lambda) \Rightarrow \psi(\lambda)$ on U . Then $\sup_n \psi_n(\lambda_0) < \infty$ and hence by (2.1) $\sup_n \tilde{n}_n(\Omega) < \infty$. Hence some subsequence $\{\tilde{n}_{n_i}\}$ of $\{\tilde{n}_n\}$ converges weakly to a bounded measure \tilde{n} , then clearly

$$\psi_{n_i}(\lambda) \rightarrow \psi(\lambda) = \int_{\Omega} \xi(\lambda; r, \theta)\tilde{n}(dr d\theta) \in \Psi.$$

LEMMA 2. Let $h_n(\lambda) = (h_1^{(n)}(\lambda), h_2^{(n)}(\lambda))$, $n = 1, 2, \dots$, and $h(\lambda) = (h_1(\lambda), h_2(\lambda))$ be functions on $\Lambda = \{\lambda = (\lambda_1, \lambda_2); \lambda_i \geq 0\}$ such that for some $V \in \Lambda$, $h_n \Rightarrow h$ on V and each h_n and h are Lipschitz continuous on V . Let $\psi_t^{(n)}(\lambda)$ and $\tilde{\psi}_t(\lambda)$ be solutions of

$$(2.2) \quad d\psi_t^{(n)}/dt = h_n(\psi_t^{(n)}), \quad \psi_{0+}^{(n)} = \lambda,$$

and

$$(2.3) \quad d\tilde{\psi}_t/dt = h(\tilde{\psi}_t), \quad \tilde{\psi}_{0+} = \lambda$$

respectively. Then there exists $V_0 \in V$ and $t_0 > 0$ such that $\psi_t^{(n)}(\lambda) \Rightarrow \tilde{\psi}_t(\lambda)$ on $(t, \lambda) \in [0, t_0] \times V_0$.

Proof. Let $h(\lambda), \tilde{h}(\lambda)$ be Lipschitz continuous in V such that

$$(2.4) \quad \sup_{\lambda \in \tilde{V}} |h(\lambda) - \tilde{h}(\lambda)| < \varepsilon$$

and

$$(2.5) \quad \sup_{\lambda, \mu \in V} |h(\lambda) - h(\mu)| \cdot |\lambda - \mu|^{-1} \leq A^{(10)}.$$

Set

$$(2.6) \quad B = \sup_{\lambda \in \tilde{V}} |h(\lambda)| + \varepsilon.$$

We claim that if ψ_t and $\tilde{\psi}_t$ are the solutions of

$$(2.7) \quad \psi_t(\lambda) = \lambda + \int_0^t h(\psi_s(\lambda)) ds$$

and

$$(2.8) \quad \tilde{\psi}_t(\lambda) = \lambda + \int_0^t \tilde{h}(\tilde{\psi}_s(\lambda)) ds$$

respectively then

$$(2.9) \quad \sup_{0 \leq t \leq t_0} \sup_{\lambda \in V_0} |\psi_t(\lambda) - \tilde{\psi}_t(\lambda)| \leq \frac{\varepsilon}{A} \exp(At_0)$$

where V_0 is a domain such that $V_0 \in V$ and $t_0 > 0$ is such that

$$\rho(V_0; \partial V) > Bt_0.$$

In fact, set $\psi_t^{(0)} = \tilde{\psi}_t^{(0)} = \lambda$ and define $\psi_t^{(n)}$ and $\tilde{\psi}_t^{(n)}$ successively by

$$\psi_t^{(n)} = \lambda + \int_0^t h(\psi_s^{(n-1)}) ds$$

and

$$\tilde{\psi}_t^{(n)} = \lambda + \int_0^t \tilde{h}(\tilde{\psi}_s^{(n-1)}) ds.$$

It is clear that if $(t, \lambda) \in [0, t_0] \times V_0$ then $\psi_t^{(n)}$ and $\tilde{\psi}_t^{(n)} \in V$ and $\psi_t^{(n)} \Rightarrow \psi_t$ and $\tilde{\psi}_t^{(n)} \Rightarrow \tilde{\psi}_t$. We shall prove that for $0 \leq t \leq t_0$

$$(2.10) \quad \sup_{0 \leq s \leq t} \sup_{\lambda \in V_0} |\psi_s^{(n)}(\lambda) - \tilde{\psi}_s^{(n)}(\lambda)| \leq \frac{\varepsilon}{A} \left[At + \frac{(At)^2}{2!} + \dots + \frac{(At)^n}{n!} \right].$$

In fact, (2.10) is trivial for $n=0$ and if we assume that (2.10) is valid for $n=0, 1, 2, \dots, n$ then for $\lambda \in V_0$ and $0 \leq t \leq t_0$,

$$\begin{aligned} |\psi_t^{(n+1)}(\lambda) - \tilde{\psi}_t^{(n+1)}(\lambda)| &\leq \int_0^t |h(\psi_s^{(n)}) - \tilde{h}(\tilde{\psi}_s^{(n)})| ds \\ &\leq \int_0^t |h(\psi_s^{(n)}) - h(\tilde{\psi}_s^{(n)})| ds + \int_0^t |(h(\tilde{\psi}_s^{(n)}) - \tilde{h}(\tilde{\psi}_s^{(n)}))| ds \\ &\leq A \int_0^t |\psi_s^{(n)}(\lambda) - \tilde{\psi}_s^{(n)}(\lambda)| ds + \varepsilon t \\ &\leq \varepsilon \int_0^t \left[As + \frac{(As)^2}{2!} + \dots + \frac{(As)^n}{n!} \right] ds + \varepsilon t \\ &= \frac{\varepsilon}{A} \left[At + \frac{(At)^2}{2!} + \dots + \frac{(At)^{n+1}}{(n+1)!} \right]. \end{aligned}$$

Therefore (2.10) holds for every n . Letting $n \rightarrow \infty$ we have (2.9). The assertion of the lemma is clear from the inequality (2.9).

LEMMA 3. Let $h(\lambda) = (h_1(\lambda), h_2(\lambda))$ be a function defined on $\Lambda = \{\lambda: \lambda \geq 0\}$, Lipschitz continuous on a domain $V \subseteq \Lambda$. Let $F(t, \lambda)$ be a continuous function of $(t, \lambda) \in [0, \infty) \times V$, (real) analytic in $\lambda \in V$ for each fixed t and satisfy

$$(2.11) \quad \frac{\partial F}{\partial t} = h_1(\lambda) \frac{\partial F}{\partial \lambda_1} + h_2(\lambda) \frac{\partial F}{\partial \lambda_2}, \quad F(0, \lambda) = 0.$$

Then $F(t, \lambda) = 0$ for all $(t, \lambda) \in [0, \infty) \times V$.

Proof. It is sufficient to prove $F(t, \lambda) = 0$ for all $(t, \lambda) \in [0, t_0] \times V$ for some t_0 , since then $\tilde{F}(t, \lambda) = F(t + t_0, \lambda)$ is also a solution of (2.11) and hence $\tilde{F}(t, \lambda) = 0$ for all $(t, \lambda) \in [0, t_0] \times V$ i.e., $F(t, \lambda) = 0$ for all $(t, \lambda) \in [0, 2t_0] \times V$. Continuing this process we have $F(t, \lambda) = 0$ for all $(t, \lambda) \in [0, \infty) \times V$.

Since $F(t, \lambda)$ is analytic in $\lambda \in V$ for each t it is sufficient to show that $F(t, \lambda) = 0$ for all $(t, \lambda) \in [0, t_0] \times V_1$ for some $V_1 \subseteq V$. Let $\psi_t(\lambda) = (\psi_1(t, \lambda), \psi_2(t, \lambda))$ be the solution of

$$d\psi_t/dt = h(\psi_t), \quad \psi_0(\lambda) = \lambda.$$

Then there exists t_0 and $V_1 \subseteq V$ such that $\psi_t(\lambda) \in V$ for all $(t, \lambda) \in [0, t_0] \times V_1$. Set $G(\sigma, \lambda) = F(t - \sigma, \psi_\sigma(\lambda))$, $0 \leq \sigma \leq t \leq t_0$, $\lambda \in V_1$ then

$$\begin{aligned} \frac{dG}{d\sigma} &= -\frac{\partial F}{\partial t}(t - \sigma, \psi_\sigma(\lambda)) + \frac{\partial F}{\partial \lambda_1}(t - \sigma, \psi_\sigma) \frac{d\psi_1(\sigma, \lambda)}{d\sigma} + \frac{\partial F}{\partial \lambda_2}(t - \sigma, \psi_\sigma(\lambda)) \frac{d\psi_2(\sigma, \lambda)}{d\sigma} \\ &= \left(-\frac{\partial F}{\partial t} + h_1 \frac{\partial F}{\partial \lambda} + h_2 \frac{\partial F}{\partial \lambda} \right) \Big|_{\lambda = \psi_\sigma} \Big|_{t = t - \sigma} = 0 \end{aligned}$$

and hence $G(\sigma, \lambda)$ is constant in σ . In particular we have $F(t, \lambda) = G(0, \lambda) = G(t, \lambda) = F(0, \Psi_t(\lambda)) = 0$ and therefore $F(t, \lambda) = 0$ for all $(t, \lambda) \in [0, t_0] \times V_1$.

Now we shall prove Theorem 2. First, let $X = (x_t, P_x)$ be a regular C.B.P. and let T_t be its semigroup. It is easy to see that T_t is a semigroup on C_0 . Let A be the infinitesimal generator in Hille-Yosida sense of T_t and let $D(A)$ be the domain of A . Set

$$(2.12) \quad f_\lambda(x) = e^{-\lambda \cdot x}, \quad \lambda = (\lambda_1, \lambda_2) \geq 0, \quad x = (x_1, x_2) \in D.$$

Then

$$(2.13) \quad T_t f_\lambda(x) = (T_t f_\lambda(1, 0))^{x_1} (T_t f_\lambda(0, 1))^{x_2}.$$

By the regularity of X and (2.13), $T_t f_\lambda(x)$ is differentiable in t at $t=0$ for each $\lambda \gg 0$ and noting that, for some $t_0 > 0$,

$$\sup_{0 \leq t \leq t_0} T_t f_\lambda(1, 0) < 1 \quad \text{and} \quad \sup_{0 \leq t \leq t_0} T_t f_\lambda(0, 1) < 1$$

it is easy to see that $(T_t f_\lambda(x) - f_\lambda(x))/t$ converges uniformly in x when $t \downarrow 0$. Hence $\{f_\lambda : \lambda \gg 0\} \subset D(A)$. By (2.13) we have also

$$(2.14) \quad Af_\lambda(x) = \lim_{t \downarrow 0} \frac{T_t f_\lambda(x) - f_\lambda(x)}{t} = e^{-\lambda \cdot x} \{e^{\lambda_1} Af_\lambda(1, 0)x_1 + e^{\lambda_2} Af_\lambda(0, 1)x_2\}.$$

We shall now determine the expression of $Af_\lambda(1, 0)$ and $Af_\lambda(0, 1)$. More generally we shall determine the expression of Af_λ at a boundary point x_0 of D except origin $O^{(1)}$. Let $x_0 = (x_1^0, 0)$ where $x_1^0 > 0$ and V be a neighborhood in D of x_0 . Let $\xi_1(x), \xi_2(x) \in C_0^\infty(\mathbb{R}^n)^{(12)}$ such that $\xi_1(x) = x_1$ and $\xi_2(x) = x_2$ on some neighborhood U of the origin. Let D_{x_0} (resp. V_{x_0}) = $\{x = y - x_0; y \in D$ (resp. $y \in V\}$ and we assume $V_{x_0} \subset U$. By a result due to Venttsel' [15], there exists $\alpha^2(x_0), a(x_0), c(x_0) \geq 0, \gamma(x_0) \geq 0, \sigma(x_0) \leq 0$ and a nonnegative measure $n_{x_0}(dy)$ on $D_{x_0} - \{O\}$ with

$$\int_{V_{x_0}} \{\xi_1(y)^2 + \xi_2(y)\} n_{x_0}(dy) + n_{x_0}(D_{x_0} - V_{x_0}) < \infty$$

such that for every $f \in D(A) \cap C^2(V)$,

$$Lf(x_0) \equiv \alpha^2(x_0)f_{11}(x_0) + a(x_0)f_1(x_0) + c(x_0)f_2(x_0) - \gamma(x_0)f(x_0) + \int_{D_{x_0}} \{f(x_0 + y) - f(x_0) - \xi_1(y)f_1(x_0)\} n_{x_0}(dy) + \sigma(x_0)Af(x_0) = 0.$$

Furthermore if $\alpha^2(x_0) = a(x_0) = c(x_0) = \gamma(x_0) = \sigma(x_0) = 0$ then $n_{x_0} \neq 0$. We claim that $\sigma(x_0) \neq 0$. In fact, if $\sigma(x_0) = 0$ then since $\{f_\lambda; \lambda \gg 0\} \subset D(A) \cap C^2(V)$,

$$Lf_\lambda(x_0) = \{\lambda_1^2 \alpha^2(x_0) - \lambda_1 a(x_0) - \lambda_2 c(x_0) - \gamma(x_0) + \int_{D_{x_0}} (e^{-\lambda \cdot y} - 1 - \lambda_1 \xi_1(y)) n_{x_0}(dy)\} e^{-\lambda \cdot x_0} = 0$$

⁽¹¹⁾ $Af_\lambda(O) = 0$ for every $\lambda \gg 0$.

⁽¹²⁾ $C_0^\infty(\mathbb{R}^n) = \{f : \text{all derivatives of } f \in C_0(\mathbb{R}^n)\}$ where $C_0(\mathbb{R}^n) = \{f : \text{continuous on } \mathbb{R}^n \text{ and } \lim_{|x| \rightarrow \infty} |f(x)| = 0\}$.

for all $\lambda \gg 0$. By a standard argument this implies that $\alpha^2(x_0) = a(x_0) = c(x_0) = \gamma(x_0) = n_{x_0}(dy) = 0$ and this is a contradiction. Hence $\sigma(x_0) \neq 0$. Without loss of the generality we may assume $\sigma(x_0) = -1$ then from $Lf_\lambda(x_0) = 0$ we have

$$(2.15) \quad Af_\lambda(x_0) = \left\{ \lambda_1^2 \alpha^2(x_0) - \lambda_1 a(x_0) - \lambda_1 c(x_0) - \gamma(x_0) + \int_{D_{x_0}} (e^{-\lambda \cdot y} - 1 + \lambda_1 \xi_1(y)) n_{x_0}(dy) \right\} e^{-\lambda \cdot x_0}.$$

Set

$$(2.16) \quad h_1(\lambda) = -e^{\lambda_1} Af_\lambda(1, 0) = -\lambda_1^2 \alpha^2 + (a\lambda_1 + c\lambda_2) + \gamma - \int_{D_{(1,0)}} (e^{-\lambda \cdot y} - 1 + \lambda_1 \xi_1(y)) n_1(dy)$$

where $\alpha^2 = \alpha^2(1, 0)$, $a = a(1, 0)$, \dots , $n_1(dy) = n_{(1,0)}(dy)$. We have a similar expression for $h_2(\lambda) = -e^{\lambda_2} Af_\lambda(0, 1)$;

$$(2.17) \quad h_2(\lambda) = -e^{\lambda_2} Af_\lambda(0, 1) = -\lambda_2 \beta^2 + (b\lambda_1 + d\lambda_2) + \delta - \int_{D_{(0,1)}} (e^{-\lambda \cdot y} - 1 + \lambda_2 \xi_2(y)) n_2(dy).$$

By (2.14),

$$(2.18) \quad Af_\lambda(x) = e^{-\lambda \cdot x} (-x_1 h_1(\lambda) - x_2 h_2(\lambda)) = \left(h_1 \frac{\partial}{\partial \lambda_1} + h_2 \frac{\partial}{\partial \lambda_2} \right) f_\lambda(x).$$

If we set $x = x_0 = (x_1^0, 0)$ in (2.18) and compare this with (2.15) we see at once that

$$\alpha^2(x_0) = x_1^0 \alpha^2, \quad a(x_0) = x_1^0 a, \dots, n_{x_0}(dy) = x_1^0 n_1(dy).$$

From the last relation, since $n_{x_0}(dy)$ is a measure on $D_{x_0} - \{O\}$, by letting $x_0 \rightarrow 0$ we see at once that $n_1(dy)$ is a measure on $D - \{O\}$. Similarly $n_2(dy)$ is a measure on $D - \{O\}$. Thus we have proved that there exist $\alpha, \beta, \gamma, \delta, a, b, c, d, n_1$ and n_2 satisfying (1.10) and (1.11) such that if the operator A' is defined by (1.9) then

$$Af_\lambda = A'f_\lambda \quad \text{for all } \lambda \gg 0.$$

For any $f \in C_0^2(D)$ choose $f_n \in \mathcal{L}\{f_\lambda; \lambda \gg 0\}^{(13)}$ such that $f_n \Rightarrow f$, $\partial f_n / \partial x_i \Rightarrow \partial f / \partial x_i$ and $\partial^2 f_n / (\partial x_i \partial x_j) \Rightarrow \partial^2 f / (\partial x_i \partial x_j)$ ($n \rightarrow \infty$) then $Af_n = A'f_n \rightarrow A'f$ and hence by the closedness of the operator A , we have $C_0^2(D) \subset D(A)$ and for $f \in C_0^2(D)$, $Af = A'f$.

Since $f_\lambda \in D(A)$ we have

$$\partial T_t f_\lambda / \partial t = AT_t f_\lambda = T_t A f_\lambda.$$

By (2.18),

$$\frac{\partial T_t f_\lambda}{\partial t} = T_t A f_\lambda = T_t \left(h_1 \frac{\partial f_\lambda}{\partial \lambda_1} + h_2 \frac{\partial f_\lambda}{\partial \lambda_2} \right) = h_1 \frac{\partial T_t f_\lambda}{\partial \lambda_1} + h_2 \frac{\partial T_t f_\lambda}{\partial \lambda_2}$$

⁽¹³⁾ $\mathcal{L}\{f_\lambda; \lambda \gg 0\}$ is the linear hull of $\{f_\lambda; \lambda \gg 0\}$.

and this proves $T_t f_\lambda(x) = F(t, \lambda; x)$ is a solution of the forward equation (1.16). If we set $\exp(-\psi_1(t, \lambda)) = T_t f_\lambda(1, 0)$ and $\exp(-\psi_2(t, \lambda)) = T_t f_\lambda(0, 1)$ then for $i = 1, 2$,

$$\begin{aligned} \frac{d\psi_i(t, \lambda)}{dt} &= -\exp(\psi_i(t, \lambda)) \frac{\partial T_t f_\lambda}{\partial t}(1, 0) = -\exp(\psi_i(t, \lambda)) A T_t f_\lambda(1, 0) \\ &= -\exp(\psi_i(t, \lambda)) A(f_{\psi_i(t, \lambda)}) = h_i(\Psi_t) \quad (\Psi_t = (\psi_1(t, \lambda), \psi_2(t, \lambda))) \end{aligned}$$

proving that Ψ_t is a solution of the backward equation (1.15).

Next we shall prove the existence of C.B.P. First we shall prove the uniqueness. Let T_t and \tilde{T}_t be strongly continuous semigroups on $C_0(D)$ with the infinitesimal generators A and \tilde{A} respectively such that $C_0^2(D) \subset D(A) \cap D(\tilde{A})$, $A = \tilde{A}$ on $C_0^2(D)$ and the expression of A on $C_0^2(D)$ is given by (1.9). Then $T_t f_\lambda(x)$ and $\tilde{T}_t f_\lambda(x)$ satisfy the forward equation with the same initial value $e^{-\lambda \cdot x}$ and hence $F(t, \lambda) = T_t f_\lambda(x) - \tilde{T}_t f_\lambda(x)$ satisfies

$$\frac{\partial F}{\partial t} = h_1(\lambda) \frac{\partial F}{\partial \lambda_1} + h_2(\lambda) \frac{\partial F}{\partial \lambda_2}, \quad F(0+, \lambda) = 0.$$

By Lemma 3, $F(t, \lambda) \equiv 0$, i.e., $T_t f_\lambda = \tilde{T}_t f_\lambda$ for every $\lambda \gg 0$. Since the linear hull $\{f_\lambda; \lambda \gg 0\}$ is dense in $C_0(D)$ we have $T_t = \tilde{T}_t$.

Now we shall prove the existence. Given $\alpha, \beta, \gamma, \delta, a, b, c, d, n_1$ and n_2 satisfying the conditions (1.10) and (1.11) define $h_1(\lambda)$ and $h_2(\lambda)$ by (1.13). By the correspondence between C.B.P.'s and Ψ^2 -semigroups established in Theorem 1 it is sufficient to prove that the solution $\Psi_t(\lambda)$ of the backward equation:

$$(1.5) \quad d\Psi_t/dt = h(\Psi_t), \quad \Psi_{0+} = \lambda$$

where $h = (h_1, h_2)$ defines a Ψ^2 -semigroup. In fact it is easy to see that the C.B.P. corresponding to Ψ_t by Theorem 1 has the semigroup T_t with the infinitesimal generator A such that $\{f_\lambda; \lambda \gg 0\} \subset D(A)$ and $A f_\lambda(x)$ is given by (2.18). Hence by the same argument as above $C_0^2(D) \subset D(A)$ and the expression of A on $C_0^2(D)$ is given by (1.9). To show that Ψ_t is a Ψ^2 -semigroup it is clearly sufficient to prove that for some $t_0 > 0$, $\Psi_t \in \Psi^2$, $t \in [0, t_0]$ and $\Psi_{t+s}(\lambda) = \Psi_t(\Psi_s(\lambda))$ for all $t, s \in [0, t_0]$ such that $t+s \in [0, t_0]$; then $\{\Psi_t\}_{t \in [0, t_0]}$ can be extended uniquely to a Ψ^2 -semigroup $\{\Psi_t\}_{t \in [0, \infty)}$. Since $h(\lambda)$ is Lipschitz continuous on every domain $U \subseteq \Lambda = \{\lambda; \lambda \geq 0\}$, the solution of (1.15) exists uniquely on U in $t \in [0, t_0]$ for some $t_0 > 0$. The semigroup property of Ψ_t is clear from the uniqueness of the solution. Hence what remains to be proved is that $\Psi_t \in \Psi^2$ for all $t \in [0, t_0]$. For this we first consider the following simple case:

$$(2.19) \quad \alpha^2 = \beta^2 = 0, \quad n_1(D - \{O\}) + n_2(D - \{O\}) < \infty.$$

Then it is easy to see that h_1 and h_2 can be represented in the form

$$(2.20) \quad h_i(\lambda) = \sigma_i(\varphi_i(\lambda) - \lambda_i), \quad i = 1, 2,$$

where σ_i ($i = 1, 2$) are positive constants and $\varphi_i \in \Psi$, ($i = 1, 2$). Then the equation

(1.15) is equivalent to the following integral equation

$$(2.21) \quad \psi_i(t, \lambda) = e^{-\sigma_i t} \lambda_i + \sigma_i \int_0^t e^{-\sigma_i(t-s)} \varphi_i(\psi_s) ds, \quad i = 1, 2.$$

Now if we define $\Psi_i^{(n)}(\lambda) = (\psi_1^{(n)}(t, \lambda), \psi_2^{(n)}(t, \lambda))$ successively by

$$(2.22) \quad \begin{aligned} \psi_i^{(0)}(t, \lambda) &= \lambda_i, \\ \psi_i^{(n)}(t, \lambda) &= e^{-\sigma_i t} \lambda_i + \sigma_i \int_0^t e^{-\sigma_i(t-s)} \varphi_i(\psi_s^{(n-1)}) ds, \quad i = 1, 2, \end{aligned}$$

then noting that Ψ^2 is closed under the composition we see easily by induction that $\Psi_i^{(n)} \in \Psi^2$. Hence by Lemma 1, $\Psi_t \in \Psi^2$ as the uniform limit of $\Psi_i^{(n)}$ on a domain $U \subseteq \Lambda$. To prove the general case we remark first that given $h = (h_1, h_2)$ there exists a sequence $h_n = (h_1^{(n)}, h_2^{(n)})$ such that for each n , h_n has the property (2.19) and $h_n \Rightarrow h$ on every $U \subseteq \Lambda$. This is a well known fact and can be proved in a similar method as the proof of Lemma 1. Let $\Psi_i^{(n)}$ be the solution of (1.15) corresponding to h_n then $\Psi_i^{(n)} \in \Psi^2$ and by Lemma 2, $\Psi_i^{(n)} \Rightarrow \Psi_t$ on some $U_0 \subseteq \Lambda$ and $t \in [0, t_0]$. Hence by Lemma 1, $\Psi_t \in \Psi^2$ and the proof of Theorem 2 is now complete.

Consider the C.B.P. $X = (x_t, P_x)$ of Theorem 2. Since its semigroup is strongly continuous on $C_0(D)$, X is a standard process or Hunt process, cf. Dynkin [1]. In particular we may assume that it is a strong Markov process with right continuous and d_1 -discontinuous sample functions. It is a diffusion process, i.e., its sample functions are continuous with probability one if and only if $\gamma = \delta = n_1 = n_2 = 0$. A probabilistic meaning of γ, δ, n_1, n_2 is the following. Define a non-negative kernel $n(x, dy)$ on $D \times \bar{D}$ by

$$(2.23) \quad \begin{aligned} n(x, E) &= x_1 n_1(E_x \cap D) + x_2 n_2(E_x \cap D) + (\gamma x_1 + \delta x_2) \delta_\Delta(E), \\ &E \in \mathcal{B}(\bar{D}), x = (x_1, x_2)^{(14)}. \end{aligned}$$

Let $f(x, y)$ be any nonnegative function on $\bar{D} \times \bar{D}$ such that $f(x, x) = 0$ for all $x \in \bar{D}$. Then for every $x \in D$ and $t \geq 0$ we have

$$(2.24) \quad E_x \left[\sum_{s \leq t} f(x_{s-}, x_s) \right] = E \left[\int_0^t \left\{ \int_{\bar{D}} f(x_s, y) n(x_s, dy) \right\} ds \right]$$

where x_{s-} is the left hand limit of x_t at s (cf. Watanabe [16]).

3. The case of diffusion processes. In this section we shall study the case of diffusion processes, i.e., the case $\gamma = \delta = n_1 = n_2 = 0$. The infinitesimal generator A given in Theorem 2 has now the following form:

$$(3.1) \quad Af = \alpha^2 x_1 f_{11} + \beta^2 x_2 f_{22} + (ax_1 + bx_2) f_1 + (cx_1 + dx_2) f_2.$$

⁽¹⁴⁾ $E_x = \{y - x; y \in E\}$, $\mathcal{B}(\bar{D})$ is the set of all Borel subsets of D^* and $\delta_\Delta(E)$ is the unit measure on the point at infinity Δ .

If $b=c=0$ then the corresponding C.B.P. is the direct product of two one-dimensional Feller diffusions. This class of 2-dimensional diffusions was discussed by Feller [2] in connection with Galton-Watson processes of two types.

The behavior of sample functions on x_1 axis when $c=0$ (or on x_2 -axis when $b=0$) is the following. If a sample path reaches the x_1 -axis then it remains on x_1 -axis moving as a one-dimensional Feller diffusion determined by the infinitesimal generator $\alpha^2 x(d^2/dx^2) + ax(dx/dx)$. Finally it hits the origin O and then it is stopped. The probability that a sample function hits the x_1 -axis is positive if $\beta \neq 0$.

From now on we shall consider the case when $b > 0$ and $c > 0$. Assume for simplicity that $\alpha = \beta = 1$. It is natural to expect that the process $X = (x_t, P_x)$ is obtained as a solution of the following stochastic equation;

$$(3.2) \quad \begin{aligned} dx_1(t) &= (x_1(t)^+)^{1/2} dB_t^{(1)} + (ax_1(t) + bx_2(t)) dt^{(15)}, \\ dx_2(t) &= (x_2(t)^+)^{1/2} dB_t^{(2)} + (cx_1(t) + dx_2(t)) dt. \end{aligned}$$

where $B_t^{(1)}$ and $B_t^{(2)}$ are mutually independent Wiener processes. The coefficients are Lipschitz continuous on every $U \subseteq D$ and hence by Ito's theorem (cf. [6], [13]) the solution of (3.2) exists uniquely up to the first hitting time for the boundary. Since the coefficients are not Lipschitz continuous we cannot apply Ito's theorem for existence and uniqueness of a global solution of (3.2) but we have the following

THEOREM 3. *For any $x \in D$, there exists a unique solution $x_t = (x_1(t), x_2(t))$ of the equation (3.2) with $x_0 = x$ such that it is stopped at the origin after it hits there for the first time. The solution defines a diffusion process $X = (x_t, P_x)$ and this coincides with the C.B.P. given in Theorem 2.*

Proof. Since the coefficients are continuous on the whole plane there exists a solution of (3.2) for any initial value $x_0 = x \in R^n$ by Skorohod's existence theorem [13, p. 59]. We modify this solution so that it is stopped at the origin after it hits there for the first time. This gives also a solution of (3.2). If the initial point x is in D then this solution x_t never leaves D . In fact, if it leaves D , there exists some time interval $[t_0, t_1]$ such that $x_{t_0} \in \partial D$, say on x_1 -axis (i.e., $x_2(t_0) = 0$) and $x_2(t) < 0$ for $t \in [t_0, t_1]$. But on a neighborhood of x_{t_0} , $cx_1 + dx_2 \geq \varepsilon > 0$ for some positive constant ε and hence $x_2(t) - x_2(s) = \int_s^t [cx_1(u) + dx_2(u)] du \geq \varepsilon(t - s)$ for every $s, t \in [t_0, t]$. This implies that $x_2(t) \geq x_2(t_0) + \varepsilon(t - t_0)$ and contradicts with $x_2(t) < 0$ for $t \in [t_0, t_1]$.

Now we shall show the uniqueness of such solutions. It is sufficient to show the uniqueness of the solution on a neighborhood of each boundary point since then the uniqueness of the global solution follows from the usual piecing out method. Let $x^{(0)} = (x_1^0, 0)$, $x_1^0 > 0$ and U be a sufficiently small neighborhood of x_0 such that $cx_1 + dx_2 > \varepsilon > 0$ on U where ε is a positive constant. Let x_t and \tilde{x}_t be two solutions such that $x_0 = \tilde{x}_0 = x^{(0)}$. We shall now prove $x_t = \tilde{x}_t$ for $t < \tau_U$ where τ_U is the first leaving time from U . Let $A(x)$, $B(x)$, $C(x)$ and $D(x)$ be bounded continuous

⁽¹⁵⁾ $x_t = (x_1(t), x_2(t))$, $\alpha^+ = \alpha \vee 0$.

functions on R^2 such that

- (i) $A(x) \equiv A(x_1)$; a function of x_1 only and $A(x_1) = (x_1^+)^{1/2}$ on U ,
- (ii) $B(x) = B(x_2)$; a function of x_2 only and $B(x_2) = (x_2^+)^{1/2}$ on U and $B(x_2) \leq (2x_2^+)^{1/2}$, everywhere,
- (iii) $C(x) = ax_1 + bx_2$ on U ,
- (iv) $D(x) = cx_1 + dx_2$ on U and $D(x) \geq \epsilon$ everywhere,
- (v) A, C, D are Lipschitz continuous and $B(x)$ is Lipschitz continuous on $|x_2| > k > 0$ for every $k > 0$.

Clearly such A, B, C and D exist. In order to show that $x_t = \bar{x}_t$ for $t < \tau_U$ it is sufficient to prove that, if y_t and \bar{y}_t are two solutions of

$$(3.3) \quad \begin{aligned} dx_1(t) &= A(x_t) dB_t^{(1)} + C(x_t) dt, \\ dx_2(t) &= B(x_t) dB_t^{(2)} + D(x_t) dt \end{aligned}$$

such that $y_0 = \bar{y}_0 = x^{(0)}$, then $y_t \equiv \bar{y}_t$. First we remark that by the same argument as above we can prove that any solution $y_t = (y_1(t), y_2(t))$ of (3.3) with $y_0 = x^{(0)}$ satisfies $y_2(t) \geq 0$ for all $t \geq 0$.

LEMMA 4. *There exists $\alpha, 0 < \alpha < 1$ such that if $y_t = (y_1(t), y_2(t))$ is a solution of (3.3) with $y_0 = x^{(0)}$ then*

$$(3.4) \quad \int_0^t E\{y_2(s)^{\alpha-1}\} ds \quad \left(= E\left\{ \int_0^t y_2(s)^{\alpha-1} ds \right\} \right) < \infty.$$

Proof. Let $\eta > 0$; then by a formula on stochastic integrals due to Ito (cf. [6], [13])

$$\begin{aligned} (y_2(t) + \eta)^\alpha - \eta^\alpha &= \alpha \int_0^t (y_2(s) + \eta)^{\alpha-1} B(y_s) dB_s^{(2)} + \alpha \int_0^t (y_2(s) + \eta)^{\alpha-1} D(y_s) ds \\ &\quad + \frac{\alpha(\alpha-1)}{2} \int_0^t (y_2(s) + \eta)^{\alpha-2} B^2(y_s) ds. \end{aligned}$$

By taking the expectations of both sides we have

$$\begin{aligned} E\{(y_2(t) + \eta)^\alpha\} - \eta^\alpha &= \alpha \int_0^t E\{(y_2(s) + \eta)^{\alpha-1} D(y_s)\} ds \\ &\quad + \frac{\alpha(\alpha-1)}{2} \int_0^t E\{(y_2(s) + \eta)^{\alpha-2} B^2(y_s)\} ds. \end{aligned}$$

By the properties of B and $D, B^2(y) \leq 2y_2^+$ and $D \geq \epsilon$ and hence if $1 - \epsilon < \alpha < 1$ then

$$\begin{aligned} E\{(y_2(t) + \eta)^\alpha\} - \eta^\alpha &\geq \alpha\epsilon \int_0^t E\{(y_2(s) + \eta)^{\alpha-1}\} ds \\ &\quad - \alpha(1-\alpha) \int_0^t E\{(y_2(s) + \eta)^{\alpha-2} y_2(s)\} ds \\ &\geq \alpha\{\epsilon - (1-\alpha)\} \int_0^t E\{(y_2(s) + \eta)^{\alpha-1}\} ds. \end{aligned}$$

Letting $\eta \downarrow 0$ we have

$$\infty > E\{y_2(t)^\alpha\} \geq \alpha\{\epsilon - (1-\alpha)\} \int_0^t E\{y_2(s)^{\alpha-1}\} ds$$

proving (3.4).

Now we shall prove $y_i = \tilde{y}_i$. The following argument was suggested by a beautiful proof of Tanaka [14] for the uniqueness of solutions with coefficients Hölder continuous of exponent $> 1/2$. Let $f_n(\alpha)$, $\alpha \in R^1$, be defined by

$$(3.5) \quad \begin{aligned} f_n(\alpha) &= |\alpha|, & |\alpha| > 1/n, \\ &= (1 + n^2\alpha^2)/2n, & |\alpha| \leq 1/n. \end{aligned}$$

By Ito's formula on stochastic integrals we have

$$(3.6) \quad \begin{aligned} &f_n(y_2(t) - \tilde{y}_2(t)) \\ &= \int_0^t f_n'(y_2(s) - \tilde{y}_2(s))(B(y_s) - (B\tilde{y}_s)) dB_s^{(2)} + \int_0^t f_n'(y_2(s) - \tilde{y}_2(s)) \\ &\quad \times (D(y_s) - D(\tilde{y}_s)) ds + \frac{1}{2} \int_0^t f_n''(y_2(s) - \tilde{y}_2(s))(B(y_s) - B(\tilde{y}_s))^2 ds \\ &= I_1 + I_2 + I_3, \quad \text{say.} \end{aligned}$$

Then⁽¹⁶⁾

$$\begin{aligned} E\{f_n(y_2(t) - \tilde{y}_2(t))\} &\rightarrow E|y_2(t) - \tilde{y}_2(t)|, & (n \rightarrow \infty) \\ E\{I_1\} &= 0 & \text{for every } n, \end{aligned}$$

and

$$E\{I_2\} \leq K_1 \int_0^t E\{|y_1(s) - \tilde{y}_1(s)| + |y_2(s) - \tilde{y}_2(s)|\} ds$$

since $f_n'(\alpha)$ is uniformly bounded and $D(y)$ is Lipschitz continuous. If $y, y' \in D$

$$|B(y) - B(y')|^2 \leq K_2 |y_2^{1/2} - y_2'^{1/2}|^2 \leq K_3 |y_2 - y_2'|^{2-\alpha} y_2^{\alpha-1}$$

for every α ($0 < \alpha < 1$). Then

$$\begin{aligned} I_3 &= \frac{1}{2} \int_0^t f_n''(y_2(s) - \tilde{y}_2(s))(B(y_s) - B(\tilde{y}_s))^2 ds \\ &= \frac{n}{2} \int_0^t I\left\{|y_2(s) - \tilde{y}_2(s)| \leq \frac{1}{n}\right\} (B(y_s) - B(\tilde{y}_s))^2 ds^{(17)} \\ &\leq K_3 \frac{n}{2} n^{\alpha-2} \int_0^t y_2(s)^{\alpha-1} ds \end{aligned}$$

and hence, if we choose α so that (3.4) holds, $E\{I_3\} \rightarrow 0$ when $n \rightarrow \infty$. Therefore

$$(3.7) \quad E\{|y_2(t) - \tilde{y}_2(t)|\} \leq K_1 \int_0^t E\{|y_1(s) - \tilde{y}_1(s)| + |y_2(s) - \tilde{y}_2(s)|\} ds.$$

By a similar argument we can prove

$$(3.8) \quad E\{|y_1(t) - \tilde{y}_1(t)|\} \leq K_4 \int_0^t E\{|y_1(s) - \tilde{y}_1(s)| + |y_2(s) - \tilde{y}_2(s)|\} ds.$$

⁽¹⁶⁾ In the following K_1, K_2, \dots are positive constants.

⁽¹⁷⁾ I_E denotes the indicator function of an event E .

In fact,

$$\begin{aligned}
 I_3 &\equiv \frac{1}{2} \int_0^t f_n''(y_1(s) - \tilde{y}_1(s))(A(y_s) - A(\tilde{y}_s))^2 ds \\
 &= \frac{n}{2} \int_0^t I \left\{ |y_1(s) - \tilde{y}_1(s)| \leq \frac{1}{n} \right\} (A(y_s) - A(\tilde{y}_s))^2 ds \\
 &\leq \frac{K_5}{2} n \int_0^t I \left\{ |y_1(s) - \tilde{y}_1(s)| \leq \frac{1}{n} \right\} (y_1(s) - \tilde{y}_1(s))^2 ds \\
 &\leq \frac{K_5}{2} n \cdot n^{-2} t \rightarrow 0, \quad (n \rightarrow \infty)
 \end{aligned}$$

by the Lipschitz continuity of A and hence we get (3.8) just as above. From (3.7) and (3.8), if we set

$$A(t) = E\{|y_1(t) - \tilde{y}_1(t)| + |y_2(t) - \tilde{y}_2(t)|\},$$

then we have

$$A(t) \leq K_6 \int_0^t A(s) ds$$

and hence $A(t) \equiv 0$ by a usual argument. Thus $y_t \equiv \tilde{y}_t$.

Finally we shall show that the diffusion process $X = (x_t, P_x)$ defined by the above unique solution of (3.2) coincides with the C.B.P. of Theorem 2. Again by Ito's formula we have for every $\lambda \gg 0$,

$$\begin{aligned}
 e^{-\lambda \cdot x_t} - e^{-\lambda \cdot x_0} &= \lambda_1 \int_0^t x_1(s)^{1/2} e^{-\lambda \cdot x_s} dB_s^{(1)} + \lambda_2 \int_0^t x_2(s)^{1/2} e^{-\lambda \cdot x_s} dB_s^{(2)} \\
 &\quad + \frac{\lambda_1^2}{2} \int_0^t x_1(s) e^{-\lambda \cdot x_s} ds + \frac{\lambda_2^2}{2} \int_0^t x_2(s) e^{-\lambda \cdot x_s} ds \\
 &\quad - \lambda_1 \int_0^t (ax_1(s) + bx_2(s)) e^{-\lambda \cdot x_s} ds \\
 &\quad - \lambda_2 \int_0^t (cx_1(s) + dx_2(s)) e^{-\lambda \cdot x_s} ds
 \end{aligned}$$

and hence by taking the expectation of both sides

$$\begin{aligned}
 E_x(e^{-\lambda \cdot x_t}) &= e^{-\lambda \cdot x} - h_1(\lambda) E_x \left\{ \int_0^t x_1(s) e^{-\lambda \cdot x_s} ds \right\} - h_2(\lambda) E_x \left\{ \int_0^t x_2(s) e^{-\lambda \cdot x_s} ds \right\} \\
 &= e^{-\lambda \cdot x} + \int_0^t \left[\left(h_1 \frac{\partial}{\partial \lambda_1} + h_2 \frac{\partial}{\partial \lambda_2} \right) E_x(e^{-\lambda \cdot x_s}) \right] ds.
 \end{aligned}$$

Hence $F(t, \lambda; x) = E_x(e^{-\lambda \cdot x_t})$ satisfies the forward equation

$$(1.16) \quad \frac{\partial F}{\partial t} = h_1(\lambda) \frac{\partial F}{\partial \lambda_1} + h_2(\lambda) \frac{\partial F}{\partial \lambda_2}, \quad F(0+, \lambda; x) = e^{-\lambda \cdot x}.$$

By Lemma 3, X coincides with C.B.P. of Theorem 2.

REMARK. The branching property of $X=(x_t, P_x)$ can be seen directly in the following way: we have shown above that $F(t, \lambda; x)=E_x(e^{-\lambda \cdot x_t})$ is the solution of the forward equation (1.16). On the other hand, as is easily seen, $\tilde{F}(t, \lambda; x) = E_{(1,0)}(e^{-\lambda \cdot x_t})^{x_1} E_{(0,1)}(e^{-\lambda \cdot x_t})^{x_2}$ satisfies (1.16). Hence by the uniqueness of the solution of the forward equation (Lemma 3) we have $\tilde{F}(t, \lambda; x)=F(t, \lambda; x)$ i.e., X has the branching property.

From Lemma 4 we have at once the following

COROLLARY. *If $\alpha=\beta=1, b>0$ and $c>0$ then the diffusion $X=(x_t, P_x)$ has the following property; with probability one the Lebesgue measure of the set of all t such that $x_t \in \partial D - \{O\}$ (x_1 -axis or x_2 -axis except origin) is 0.*

This fact is in striking contrast to the case when $b=0$ or $c=0$. We shall study in more detail the behavior of sample functions near the boundary. Set

$$(3.9) \quad \Sigma_1 = \{x = (x_1, 0); 1/c < x_1 < \infty\},$$

$$(3.10) \quad \Sigma_2 = \{x = (x_1, 0); 0 < x_1 < 1/c\},$$

$$(3.11) \quad \Sigma_3 = \{x = (0, x_2); 0 < x_2 < 1/b\},$$

and

$$(3.12) \quad \Sigma_4 = \{x = (0, x_2); x_2 > 1/b\}.$$

Let $\bar{x} \in \partial D - \{O\}$ and U be a neighborhood in D of \bar{x} which has the strictly positive distance from the origin. For simplicity we assume that \bar{x} is on x_1 -axis. For each $\eta > 0$ set

$$(3.13) \quad U^\eta = U \cap \{x = (x_1, x_2); x_2 > \eta\}$$

and let τ_η be the first leaving time from U^η . Set $\sigma = \lim_{\eta \downarrow 0} \tau_\eta$ and

$$(3.14) \quad \Gamma_U^\sigma = \text{the (random) set of all limit points of } x_t \text{ when } t \uparrow \sigma.$$

Following Has'minsky [4], we shall give the following

DEFINITION 1.5. \bar{x} is called *regular* if for every neighborhood V in D of \bar{x} we have

$$(3.15) \quad \lim_{x \in D^\circ \rightarrow \bar{x}} P_x\{\Gamma_U^\sigma \subset V \cap \partial D\} = 1$$

where U is a fixed neighborhood of \bar{x} .

DEFINITION 1.6. Let Σ be an open interval in $\partial D - \{O\}$. Σ is called *unattainable* if for every $\bar{x} \in \Sigma$ there exists a neighborhood U in D of \bar{x} such that

$$(3.16) \quad P_x(\Gamma_U^\sigma \cap \partial D = \emptyset) = 1, \quad \text{for every } x \in U \cap D^\circ.$$

It is clear from these definitions that

- (i) if Σ is unattainable then Σ consists of all irregular points,

(ii) Σ is unattainable if and only if each $x \in \Sigma$ has a neighborhood in Σ which is unattainable,

(iii) if Σ is unattainable then with probability one sample functions starting from a point in D° never hit Σ .

THEOREM 4. (i) Σ_2 and Σ_3 consist of all regular points. Furthermore sample functions hit any nonempty open set in $\Sigma_2 \cup \Sigma_3$ in a finite time with positive probability.

(ii) Σ_1 and Σ_4 are unattainable.

Proof. Let $\bar{x} = (\bar{x}_1, 0) \in \Sigma_2$, i.e., $0 < c\bar{x}_1 < 1$ and I be a neighborhood in Σ_2 of \bar{x} . According to [4] set

$$A_*(x_2) = \min_{x_1 \in I} \frac{x_2}{x_1 + |ax_1 + bx_2|}, \quad B^*(x_2) = \max_{x_1 \in I} \frac{cx_1 + dx_2}{x_2}$$

then it is easy to see that, if I is sufficiently small, then there exist constants $0 < k_1 < k_2, 0 < k_3 < k_4 < 1$ such that $k_1x_2 \leq A^*(x_2) \leq k_2x_2$ and $k_3/x_2 \leq B^*(x_2) \leq k_4/x_2$. Then

$$Z^*(x_2) = \exp \left\{ \int_{x_2} B^*(z) dz \right\} \cdot \int_{x_2} \left[\exp \left\{ \int_z B^*(u) du \right\} \cdot A_*(z) \right]^{-1} dz \leq k_5 x_2^{-k_4}$$

and hence $\int_{0+} Z^*(x_2) dx_2 < \infty$. By Theorem 3.1 of [4] \bar{x} is regular. Next we shall show that sample functions hit every nonempty open subset of Σ_2 with positive probability. Let $\bar{x} \in \Sigma_2$ and U be a neighborhood in D of \bar{x} such that $cx_1 + dx_2 \geq \epsilon > 0$ on U where ϵ is a positive constant. Let $u(x) \in C_0^2(D)$ such that $u(x) = x_2$ on U then $u(x) \in D(A)$ by Theorem 2 and $Au(x) = cx_1 + dx_2 \geq \epsilon$ on U . Let σ be the first leaving time from $U \cap D^\circ$ and let $\sigma^n = \sigma \wedge n$. By Dynkin's formula [1] we have for any $x \in U \cap D^\circ$

$$E_x(u(x_{\sigma^n})) - u(x) = E_x \left[\int_0^{\sigma^n} Au(x_s) ds \right] \geq \epsilon E_x[\sigma^n]$$

and letting $n \rightarrow \infty, E_x(\sigma) \leq (2/\epsilon)\|u\| < \infty$. Hence $P_x[\sigma < \infty] = 1$. If $P_x[x_{\sigma} \in \partial D] = 0, x \in U \cap D^\circ$ ⁽¹⁸⁾, then every point of $U \cap \partial D$ would be irregular and this contradicts with what we have already proved. Hence $P_x[x_{\sigma} \in \partial D] > 0$ for every $x \in D^\circ \cup U$.

Finally we shall show that $\Sigma_1 \cup \Sigma_4$ is unattainable. Let $\bar{x} = (\bar{x}_1, 0) \in \Sigma_1$, i.e., $c\bar{x}_1 > 1$. Let I be a neighborhood in Σ_1 of \bar{x} and set

$$A^*(x_2) = \max_{x_1 \in I} \frac{x_2}{x_1 + |ax_1 + bx_2|}, \quad B_*(x_2) = \min_{x_1 \in I} \frac{cx_1 + dx_2}{x_2}$$

If I is sufficiently small then there exist constants $k_1 > 0, 1 < k_2 < k_3$ such that

⁽¹⁸⁾ Note that if $P_x[x_{\sigma} \in \partial D] = 0$ for at least one point $x \in D^\circ \cup U$ then $P_x[x_{\sigma} \in \partial D] \equiv 0$ on $D^\circ \cup U$ since it is an A -harmonic function.

$A^*(x_2) \leq k_1 x_2$ and $k_2/x_2 \leq B^*(x_2) \leq k_3/x_2$. Then

$$Z_*(x_2) = \exp \left\{ \int_{x_2} B_*(z) dz \right\} \cdot \int_{x_2} \left[\exp \left\{ \int_z B_*(u) du \right\} A^*(z) \right]^{-1} dz \geq k_4 x_2^{-k_2}$$

and hence $\int_{0+} z(x_2) dx_2 = +\infty$. By Theorem 3.2 of [4] \bar{x} has a neighborhood in Σ_2 which is unattainable.

Irregularity of a point Σ_1 (or Σ_4) is seen more directly in the following way. Let $\bar{x} = (\bar{x}_1, 0)$ such that $c\bar{x}_1 > 1$ and let U be a neighborhood of \bar{x} such that it is surrounded by a segment $[\sigma_1, \sigma_2]$ on x_1 -axis ($1/c < \sigma_1 < \bar{x}_1 < \sigma_2$) and a smooth curve γ in D° joining the points $(\sigma_1, 0)$ and $(\sigma_2, 0)$. If $k > 0$ is a constant and $u \in C^2(U)$ such that $u|_\gamma = 0$ then by Green's formula we have easily that

$$\begin{aligned} \iint_U (A-k)u \cdot u \, dx &= - \iint_U \{x_1 u_1^2 + x_2 u_2^2\} \, dx - \left(k + \frac{b}{2} + \frac{d}{2}\right) \iint_U u^2 \, dx \\ &\quad - \frac{1}{2} \int_{\sigma_1}^{\sigma_2} (cx_1 - 1)u^2(x_1, 0) \, dx_1. \end{aligned}$$

Hence if $k > -b/2 - \alpha/2$ and $(A-k)u = 0$ then $u \equiv 0$ in U . This shows that any solution of $(A-k)u = 0$ is uniquely determined by the boundary value on the part γ of the boundary and hence every point $x \in U \cap \partial D$ must be irregular points⁽¹⁹⁾.

By Corollary of Theorem 3 the Lebesgue measure of the set of all t such that $x_t \in \partial D - \{O\}$ is zero with probability one. Let $\mathfrak{M}^{(20)}$ be the set of all additive functionals which are square-integrable martingales. Then by a result of [12] \mathfrak{M} is generated by

$$M_1(t) = \int_0^t x_1(t)^{1/2} dB_t^{(1)} \quad \text{and} \quad M_2(t) = \int_0^t x_2(t)^{1/2} dB_t^{(2)}.$$

Hence for every $M \in \mathfrak{M}$, $\int_0^t I_{\partial D}(x_s) dM_s = 0$. Generally it is natural to call a part Σ of the boundary a *reflecting barrier* if⁽²¹⁾

- (i) it consists of all regular points,
- (ii) the sample functions hit every nonempty open subset of Σ with positive probability,
- (iii) the set of time t such that $x_t \in \Sigma$ has the Lebesgue measure 0 with probability one,
- (iv) for every $M \in \mathfrak{M}$, $\int_0^t I_\Sigma(x_s) dM_s = 0$.

Thus we have the following

COROLLARY 1. $\Sigma = \Sigma_1 \cup \Sigma_2$ is a reflecting barrier, i.e., it satisfies the conditions (i)-(iv).

⁽¹⁹⁾ By the classification of Fichera [3], $\Sigma_1 \cup \Sigma_4$ is $\Sigma^{(1)}$ -boundary and $\Sigma_2 \cup \Sigma_3$ is $\Sigma^{(2)}$ -boundary.

⁽²⁰⁾ This class of additive functionals was studied in Motoo-Watanabe [12].

⁽²¹⁾ In the case of one-dimensional diffusion these conditions characterize a reflecting barrier among all possible boundary conditions, cf. Ito and McKean [7].

Also it is natural to call a part Σ of the boundary a *pure entrance boundary* if Σ is unattainable and every $\bar{x} \in \Sigma$ has a neighborhood U such that if τ_U is the first leaving time from U then $P_x(\tau_U < \infty) = 1$ for every $x \in U$. For any $\bar{x} \in \Sigma_1 \cup \Sigma_4$ we can show the existence of such a neighborhood U in D of \bar{x} by the same argument as above involving Dynkin's formula. Thus we have the following

COROLLARY 2. $\Sigma = \Sigma_1 \cup \Sigma_4$ is a pure entrance boundary.

4. **A remark on the regularity.** The regularity of a C.B.P. or equivalently the regularity of a Ψ^2 -semigroup follows from a much weaker condition as we shall see in the following

THEOREM 5. A C.B.P. $X = \{x_t, P_x\}$ is regular if $\Psi_t(\lambda)$ is continuous in t for each $\lambda \gg 0$.

REMARK. As Lamperti showed in Lemma 2.3 of [11] the continuity follows from the measurability and some additional condition.

Proof. From the continuity of $\Psi_t(\lambda)$ we can conclude easily that X is a Hunt process. Next we shall remark that there exist $u_1(x), u_2(x) \in D(A) \cap C^\infty(D)$ such that

$$e^{-\lambda \cdot x} = \varphi^{(\lambda)}(u(x)), \quad u(x) = (u_1(x), u_2(x)),$$

where $\varphi^{(\lambda)}(u_1, u_2)$ is a C^∞ -function defined on a domain containing the range $u(D) = \{(u_1(x), u_2(x)); x \in D\}$ and further there exists a (nonempty) domain $U \subset \Lambda = \{\lambda: \lambda \geq 0\}$ such that if $\lambda \in U$ then all $\partial \varphi^{(\lambda)} / \partial u_i, \partial^2 \varphi^{(\lambda)} / \partial u_i \partial u_j$ are bounded on $u(D)$. In fact take linearly independent $\lambda_1 \gg 0$ and $\lambda_2 \gg 0$ and set for a fixed t

$$u_i(x) = \int_0^t T_s f_{\lambda_i}(x) ds = \int_0^t e^{-\Psi_s(\lambda_i) \cdot x} ds, \quad i = 1, 2,$$

then clearly $u_i \in D(A) \cap C^\infty(D)$ and by a simple calculation it is easy to see that, if t is sufficiently small, the Jacobian $\partial(u_1, u_2) / \partial(x_1, x_2)$ never vanishes on some neighborhood of D . Hence there exists C^∞ -function $\varphi^{(\lambda)}$ such that

$$e^{-\lambda \cdot x} = \varphi^{(\lambda)}(u_1(x), u_2(x)).$$

Also it is easy to see that, if $M > 0$ is sufficiently large $U = \{\lambda = (\lambda_1, \lambda_2); \lambda_i > M, i = 1, 2\}$ possesses the above property. Then by a formula on stochastic integrals (cf. [12] for diffusion processes and Kunita and Watanabe [9] for the general Hunt processes), if $\lambda \in U$,

$$e^{-\lambda \cdot x_t} - e^{-\lambda \cdot x_0} = \text{a martingale} + \text{a continuous additive functional of bounded variation}$$

and hence it is clear that for each x and $\lambda \in U, e^{-\Psi_t(\lambda) \cdot x} = E_x(e^{-\lambda \cdot x_t})$ is a function of bounded variation in $t \in [0, T]$ for every $T > 0$. Thus $\Psi_t(\lambda)$ is a function of bounded variation in t and combining this with the semigroup property it is easy

to see that $\psi_t(\lambda)$ is differentiable in t at $t=0$ for every $\lambda \in U_0$ where U_0 is a dense subset of U . Now the first part of Theorem 2 can be proved in exactly the same way as above and hence we have the same class of C.B.P.'s. In particular this implies that $\{\psi_t\}$ is a regular Ψ^2 -semigroup.
